

RESOLUTION NO. 23-140

ADOPTING A SCHEDULE OF MAINTENANCE COSTS AND CHARGES FOR
COMMUNITY FACILITIES DISTRICTS

WHEREAS, from time to time the City authorizes the formation of a Community Facilities District (CFD) under the Mello-Roos Community Facilities Act of 1982 (Act) to be used to finance maintenance and operation of certain services authorized under the Act; and

WHEREAS, the City can uniformly identify the costs of providing many of the commonly required maintenance and operations services and activities provided within a CFD; and

WHEREAS, in an effort to support a more streamlined process for negotiating CFD conditions, improved cost recovery, and equity between districts, on March 20, 2019 the City adopted Resolution No. 19-79, Adopting a Schedule of Maintenance Costs and Charges for Community Facilities Districts; and

WHEREAS, the schedule was most recently updated effective July 1, 2022 to incorporate annual inflationary adjustments to the various maintenance costs and charges identified in the schedule based on the change in the all-urban Consumer Price Index (CPI) for the San Francisco-Oakland-Hayward area from October to October of the immediately preceding year; and

WHEREAS, staff has recently completed an updated evaluation of the costs of providing many of the commonly required maintenance and operations services and activities provided within a CFD; and

WHEREAS, staff recommends adopting the updated schedule of maintenance costs and charges for community facilities districts, effective July 1, 2023, attached hereto as Exhibit "A;" and

WHEREAS, adoption of the uniform schedule of costs for certain services and activities does not preclude the City from recovering other CFD related service and maintenance costs, authorized by the Act, that are identified and established as part of the process of forming each CFD; and

WHEREAS, implementation of this schedule of costs and charges is subject to formation of new districts to which the schedule would apply, but will not affect previously established districts or districts that have initiated proceedings, as of the date of adoption of the resolution, to form a CFD to finance services authorized by the Act; and

WHEREAS, staff further recommends authorizing the Chief Financial Officer to make automatic annual inflationary adjustments for the various maintenance costs and charges identified in the schedule based on all-urban Consumer Price Index (CPI) for the San Francisco-Oakland-Hayward area; and

WHEREAS, inflationary adjustments will be based on the CPI change from October to October of the immediately preceding year; and

WHEREAS, if the CPI does not change or goes down, no change shall be made to the schedule for that year unless an adjustment is made to targeted cost recovery levels or cost study findings indicate that an adjustment is appropriate; and

NOW THEREFORE, BE IT RESOLVED by the Council of the City of Roseville that said Schedule of Maintenance Costs and Charges for Community Facilities Districts, effective July 1, 2023 is hereby adopted.

BE IT FURTHER RESOLVED, the Chief Financial Officer has authority to make automatic annual inflationary adjustments for the various costs and charges identified in the schedule based on the yearly change in the all-urban Consumer Price Index (CPI) for the San Francisco-Oakland-Hayward area.


