GENERAL RENTAL INFORMATION

- Reservations are taken at the Maidu Community Center or Mahany Fitness Center (formerly the Roseville Sports Center). Inquiries can be made by phone by calling (916) 772-PLAY, option 1, Monday-Friday, 8am-5pm.
- Reservations accepted on a first-come, first-served basis, up to one year in advance of the rental date. Payment is due to reserve courts, no holds.
- 2 hour minimum is required on all court rentals.
- To secure your reservation, a completed application and all fees paid in full are required.
- Reservations must be made no less than 2 weeks in advance of the rental date.
- Fees are not refunded for reserved time not used.

MULTI-RENTAL DISCOUNT

- A multi-rental discount applies to any renter with 10+ court rentals per calendar year (Jan-Dec). Starting on the 11th booking each subsequent court rental in the calendar year will receive 10% off the hourly rate.
- A court rental is a specific date or space within an overall rental permit.
 - Court rental examples:
 - A rental permit with specific date and three courts rented is three rentals.
 - A rental permit with one court rented, reoccurring once each month for a year is twelve rentals and the 11th and 12th rentals would receive the 10% discount.
- Maximum discount is 10%. Discount does not apply to additional amenities or deposit.

RENTAL CANCELLATIONS

- Cancellation of reservations are subject to the following conditions and fees:
 - Rental cancellations requested 10 business days or more in advance of scheduled date:
 - City will charge a \$10 cancellation fee and remaining rental fees will be returned to the renter.
 - Rental cancellations requested less than 10 business days prior to their rental:
 - The renter forfeits their rental fees, and no additional fees are assessed.
- All cancellations are required in writing by the person who signed the contract and can be emailed, mailed or hand delivered.
- Incomplete, inaccurate, or false information listed on the rental contract may result in cancellation of the rental, and loss of security deposit and any fees paid.

RENTAL CANCELLATIONS (continued)

- The City reserves the right to cancel any event if the renter knowingly made a false statement of material fact or has knowingly omitted to state a material fact in the rental application.
- Rental date or time changes (excludes time extensions) will result in a \$10 change fee. Date and/or time changes must be made 10 business days or more prior to event. No more than three changes per rental permit. **I Understand:** _____ (initial)

PARK RULES & REGULATIONS

Initialing next to each statement indicates your understanding and adherence with the statement.

_____ All City parks close one hour after sunset. Exceptions include: lighted sports facilities, city sponsored & co-sponsored activities.

_____ No person shall bring into, possess or consume any alcoholic beverage in any park with the exception of Royer Park, Woodbridge Park, Mahany Park, Maidu Regional Park, and Saugstad Park in DESIGNATED AREAS, BY PERMIT ONLY.

_____ Smoking is PROHIBITED in ALL City parks.

_____ Glass containers are PROHIBITED in ALL City parks.

_____ Motor vehicle may only be operated on roadways and in parking areas. Vehicles are not allowed on the grass/turf or park interiors without prior approval. Your park/court reservation does not exempt you from this policy.

_____ Golfing is permitted at Diamond Oaks Municipal Golf Course and Woodcreek Golf Club ONLY. Golfing is NOT allowed at any City park.

_____ No person shall destroy, damage or deface any park property. In the event of damages to City property the sponsoring party shall be held liable and will be billed for repair and/or replacement of damaged property. Any/all deposits will NOT be returned.

_____ All users are expected to leave the park clean and orderly, cleaning and damage deposits are refunded according to the condition of the area after use. Tables should be wiped clean, any spills cleaned up and all trash picked up and bagged.

_____ It is prohibited to make loud, unnecessary noise which unreasonably disturbs the peace or causes annoyance to any park neighbor or other facility user. _____ If the City requires the presence of police officers, security guards, fire and/or medical service during the event, the sponsoring group will be held accountable for making the arrangements and paying for the services.

_____ Animals are NOT allowed in any City park with the exceptions of designated City dog parks and zones.

_____ Power/electricity is NOT provided by the City on almost all occasions. Any reservations having special equipment must provide their own power/electricity.

_____ You must receive special permission for vehicles in park areas and the placement of all special apparatuses. Please submit a map of the set-up & intended areas of use 14 days prior to your event. Park Maintenance will contact you with approval, denial or alternate set-up/locations.
